All membership applications and fees will be processed through Independence Public School, 23786 Indee Blvd., Independence, WI 54747. Checks should be made out to the Independence School District.

Approved members: To ensure the safety and security of our students all applicants will be screened for a background check. Applicants may be asked for additional specifics. If approved members will be notified and can pick up a security access card from the Student Services, Guidance and Sp. Ed. secretary during regular business hours. The access security card is to be used only by paid member. Violators may have their membership revoked.

Member parking: Members may use the parking lot by the football field.

Member Use: Members are expected to only enter through the North/Phy. Ed. door. Members are expected to remain in this area and **are not allowed in any other parts of the building.** The school security system is active from approximately 10:00 PM to 6:30 AM, and on 24 hours on weekends and holidays when school is not in session. Members who move beyond the water fountain during these times will trigger the alarm and the authorities. The gymnasium and any of the areas of the school are not authorized for members. Public use of these areas is permitted by completing a Public Use Form which can be picked up at the school office during regular business hours.

Supervision: The fitness area does not have staff monitoring the area. Monitoring of the area and members is done through access security cameras located in and around the facility. Members are only allowed in the fitness room area. Members moving into any other areas of the school are in violation of the membership agreement.

Member Use During School Hours: During the school year Phy. Ed. Classes and sports teams will be using the facility during and immediately at the end of the school day. It is understood during these times students will have priority and members may have to be flexible in use of the equipment/weights. Members are reminded that they should enter through the North Phy. Ed. door and remain in the weight room area.

Dress Apparel: We encourage you to dress appropriately for your workout in the community fitness facility. Gym shoes and workout clothes are appropriate.

Card Replacement: Lost cards will be deactivated and a replacement fee will be \$10.00.

Expectations: All members of the Independence Community Fitness Facility are expected to display community values of the Independence School District, which are Tradition, Pride, and Excellence. Members behaving inappropriately may have their membership revoked. Refunds will not be given.

- Please use disinfectant wipes to wipe off machines if you perspire on them.

In consideration of being permitted the use of the Independence School District Fitness Center ("Fitness Center"), on behalf of myself and my children, parents, heirs, assigns, personal representative(s) and estate, I agree to the following:

1. I acknowledge that Fitness Center activities involve known and unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death, and property damage. Risks include, but are not limited to, musculoskeletal injuries, broken bones, overuse injuries, injuries caused by equipment that breaks or otherwise fails, medical conditions resulting from or aggravated by physical activity; and damaged clothing or other property. I understand such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.
2. I hereby release, waive, discharge, and covenant not to sue the Independence School District and its directors, officers, employees, agents, volunteers, participants, and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees") from all liability for any and all loss or damage, and any claim or demands therefore on account of injury to my person or property or resulting in my death arising out of or related to the use of the Fitness Center, whether caused by negligence of the Releasees or otherwise.
3. I hereby agree to indemnify and save and hold harmless the Releasees from any loss, liability, damage, or cost that may incur out of my use of the Fitness Center whether caused by the negligence of the Releasees or otherwise.
4. I hereby assume full responsibility for any risk of physical or emotional injury, death, or property damage arising out of or related to the use of the Fitness Center whether caused by the negligent supervision of Releasees. My participation in this activity is purely voluntary and I elect to participate despite the risks. If at any time I believe that conditions in the Fitness Center are unsafe or that I am unable to participate in Fitness Center activities due to my physical or mental condition, I will immediately discontinue participation.
5. I hereby acknowledge that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, including negligent attempts at medical assistance by Releasees, and is intended to be as broad and inclusive as is permitted by Wisconsin law.
6. I hereby agree that my use of the Fitness Center is conditioned upon completion of a background check, and further agree that my continued use of the Fitness Center is revocable at any time for any reason.
7. I hereby waive the right I have to bargain for different waiver of liability terms. I further agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
8. I understand that during the school year Phy. Ed. Classes and sports teams will be using the facility during the school day. It is understood during these times students will have priority and members may have to be flexible in use of the equipment/weights. I agree to only enter through the North door and remain in the weight room area and not enter other parts of the building.
9. I also agree not to allow non-members to use my key/fob to enter or use the facility.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY AND INTEND BY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RRELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
